Auckland Transport is introducing changes along Carlton Gore Road aimed at improving safety, connectivity and accessibility on this busy commercial and residential street.

Cycle lanes

Cycle lanes are to be installed on both sides of Carlton Gore Road between Park Road and Davis Crescent. Cyclists will be separated from traffic by a half metre wide flush median and greening will be used to clearly mark the route. A drawing on the reverse of this letter shows the type of cycle lane that will be installed. The lanes will add to Auckland's growing cycle network, linking cyclists with a shared bus and cycle lane on Park Road, and providing an important connection from the east to the city centre.

Pedestrian crossing point

A pedestrian crossing point consisting of kerb build-outs on either side of the road will be installed outside 103 Carlton Gore Road, near to the intersection with George Street. The build outs will provide pedestrians with better visibility when they step out to cross the road.

Zebra crossing

The existing zebra crossing on Carlton Gore Road will be repositioned to sit equidistant between the Morgan Street and Kingdon Street intersections. Coloured surfacing and sensor-activated flashing LEDs will be installed to provide pedestrians with increased visibility and safety.

To accommodate the new infrastructure and maintain a safe shared environment for all road users we need to remove some parking on Carlton Gore Road. This includes:

- The section of parking on the eastbound downhill side of Carlton Gore Road, between the George Street and Park Road intersections. Approximately four car parks on the westbound uphill side of Carlton Gore Road, between 65-67 Carlton Gore Road and 71 Carlton Gore Road. This will accommodate the new cycle lanes.
- Approximately two car parks on the eastbound downhill side of Carlton Gore Road and approximately three car parks on the westbound uphill side of Carlton Gore Road, outside and opposite 103 Carlton Gore Road. This will accommodate the new crossing point.
